

MoneyHero x BOC Chill Card 條款及細則

1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞（定義如下）。

2. 推廣期

除非另有說明，推廣期為 2025/10/08 10am 至 2025/10/15 6pm，包括首尾兩天（推廣期）或申請名額已滿之截止日（以較早日子為準）。

3. 推廣活動相關定義

- a. “指定信用卡”指 中銀 Chill World Mastercard 或 中銀 Chill Platinum Mastercard。
- b. “信用卡提供者”指 中國銀行(香港)有限公司及中銀信用卡(國際)有限公司。
- c. “新客戶”指在 現時並未持有中銀信用卡主卡或過去 12 個月內未曾持有或取消任何中銀信用卡主卡之申請人。

4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”，客戶需：

- a. 為年滿 18 歲且持有有效香港身份證並在香港有通訊地址的新客戶，且需符合“指定信用卡”之申請資格；
- b. 在被重定向到信用卡提供者網站前向 MoneyHero 提供有效的電子郵件地址；
- c. 在推廣期內通過 MoneyHero 使用指定鏈接完成並提交指定信用卡的申請；
- d. 在推廣期內成功提交指定信用卡的申請後 7 天內完整填寫並提交 MoneyHero 獎賞換領表格；及
- e. 在2025/11/30或之前獲信用卡提供者批准申請指定信用卡，並以信用卡提供者系統記錄為準。

5. 推廣獎賞及兌換

Terms and Conditions of MoneyHero X BOC Chill Card Promotion

1. Eligible Customers who successfully apply for a Designated Card through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the **Promotion is from 2025/10/08 10am to 2025/10/15 6pm**, dates inclusive or the date that the application quota is full (whichever is earlier) (the **"Promotion Period"**).

3. For the purposes of this Promotion:

a. **"Designated Card"** means the **BOC Chill World Mastercard / BOC Chill Platinum Mastercard**.

b. **"Product Provider"** means **Bank of China (Hong Kong) Limited and BOC Credit Card (International) Limited**.

c. **"New Customer"** means customers who do not currently hold or have not held/cancelled any BOC credit card in the past 12 months prior to the date of such application..

4. Eligible Customers

In order to receive a Promotion Reward and to comprise **"Eligible Customers"**, customers are required to:

a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong and fulfils eligibility for "Designated Card" application;

b. Provide a valid email address to MoneyHero prior to being redirected to the Product Provider's website;

c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;

d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Card within the Promotion Period; and

e. Have their application for the Designated Card approved by the Product Provider on or before 2025/11/30, subject to the Product Provider's system records.

5. Promotion Rewards and Redemption

a. Eligible Customers who complete the conditions set out in Clause 4 above will be able to select one of the following **"Promotion Rewards"**, subject to availability:

- Marshall Emberton II Bluetooth Speaker (value of HK\$1,499); OR
- LOJEL Alto 29" Large Luggage (value of HK\$2,100).

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.

d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.

e. If the application for the Designated Card is not made via the designated link, or an ad-blocker, tracking blocker or incognito mode is enabled during the application process, it may not be counted as valid and may lead to the user not being eligible for any Promotion Reward. MoneyHero reserves the right to withhold any Promotion Reward where, according to its records, the application was not made through MoneyHero in accordance with these Terms and Conditions.

d. In the event of any inconsistencies between these Terms and Conditions and any other materials (e.g marketing materials) relating to this Promotion, these Terms and Conditions shall prevail.

e. By participating in this Promotion, users consent to (i) MoneyHero sharing their personal details with the Product Provider in order to accurately confirm whether a user is eligible to receive any Promotion Reward, (ii) the Product Provider updating MoneyHero with information regarding the status of the user's application for the Designated Card, including whether or not said application is successful and whether the user has fulfilled all the conditions required to receive the Promotion Reward, (iii) MoneyHero sharing the information provided in the MoneyHero Reward Redemption Form with MoneyHero's promotion partners as required to facilitate redemption of the Promotion Reward, and (iv) receiving communications in relation to this Promotion from MoneyHero via email or other electronic means, each in accordance with MoneyHero's Privacy Policy.
