# MoneyHero x BOC Chill Card 條款及細則

### 1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞 (定義如下)。

### 2. 推廣期

除非另有說明, 推廣期為 2025/10/08 10am 至 2025/10/15 6pm, 包括首尾兩天(推廣期)或申請名額已滿之截止日(以較早日子爲準)。

### 3. 推廣活動相關定義

- a. "指定信用卡"指 中銀 Chill World Mastercard 或 中銀 Chill Platinum Mastercard。

# Terms and Conditions of MoneyHero X BOC Chill Card Promotion

1. Eligible Customers who successfully apply for a Designated Card through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

#### 2. Promotion Period

Unless otherwise specified, the promotion period of the **Promotion is from 2025/10/08 10am to 2025/10/15 6pm**, dates inclusive or the date that the application quota is full (whichever is earlier) (the "**Promotion Period**").

## 3. For the purposes of this Promotion:
