

# (2025/09/30 6pm) MoneyHero x HASE MMPOWER World Mastercard

## 1. 合資格客戶

成功通過MoneyHero申請指定信用卡並完成本條款及細則所載的其他要求的合資格客戶將獲得推廣獎賞（定義如下）。

## 2. 推廣期

除非另有說明，推廣期為 2025/09/30 6pm 至 2025/12/31 12pm（包括首尾兩天）（“推廣期”）。

## 3. 推廣活動相關定義

- a. “指定信用卡”指 恒生MMPOWER World Mastercard。
- b. “信用卡提供者”指恆生銀行。
- c. “新客戶”指在申請指定信用卡前 12 個月內未持有恆生銀行任何信用卡的客戶。
- d. “新舊客戶合資格簽賬”指HK\$100。

## 4. 合資格客戶條件

為獲得推廣獎賞並成為“合資格客戶”，客戶需：

d. “**New and Existing Customer Eligible Spending**” means HK\$100.

## 4. Eligible Customers

- a. Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;

- c. Fully complete and submit an application for a Designated Card through MoneyHero using the designated link during the Promotion Period;
- d. Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after successfully submitting the application for the Designated Loan within the Promotion Period;
- e. Have their application for the Designated Card approved by the Product Provider on or before 2026/01/31, subject to the Product Provider’s system records; and

- HK\$600 (Deposited via FPS Account) ("Cash Reward"); OR
- Marshall Willen II Bluetooth Speaker (value of HK\$999); OR
- NESCAFÉ® Dolce Gusto® Genio S Plus with 6 boxes coffee capsules (value of HK\$1,780); OR
- Polaroid Now+ Generation 2 i-Type Instant Camera (value of HK\$1,599).

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero within 90 days. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
