

# MoneyHero x Allianz - 汽車保險推廣活動 (2025年10月至11月)(「條款及細則」)

1. 本推廣活動由 MoneyHero Insurance Brokers Limited(「MoneyHero」)代表安聯香港(「Allianz Hong Kong」)主辦。

2. 根據本條款及細則, 合資格用戶(定義如下)於推廣期內(定義如下), 透過MoneyHero的網站成功投保由安聯香港提供的合資格產品, 即有機會獲得由安聯香港提供的推廣獎賞(定義如下)。

## 3. 推廣期

除特別註明外, 此次推廣期由**2025年10月17日下午6時起至2025年11月17日下午6時止**(包括首尾兩天)(「推廣期」), 並受第5(b)條規定的推廣獎賞數量限制。

## 4. 合資格用戶

a. 要成為可獲取第5條所列明之「推廣獎賞」的「合資格用戶」, 客戶必須於推廣期內:

- i. 為18歲或以上的香港居民; 及
- ii. 於推廣期內透過MoneyHero的指定網站( <https://www.moneyhero.com.hk/zh/car-insurance> 或 <https://www.moneyhero.com.hk/zh/insurance/car-insurance/driving-tour-guide> ) 於MoneyHero投保合資格產品(定義見下文第4條)。如果未透過指定連結進行申請, 或在申請過程中啟用了廣告攔截器、追蹤攔截器或隱身模式, 則可能不會被視為有效, 並可能導致客戶沒有資格獲得任何獎賞。如果未按照本條款及細則透過MoneyHero進行申請, MoneyHero會根據其記錄, 保留扣留任何獎賞的權利; 和
- iii. 須確保合資格產品維持有效狀態, 且於**12月31日**前不得取消或退款 (以Allianz Hong Kong記錄為準)。

b. 為免生疑問, 用戶必須透過 MoneyHero 指定網站完成合資格產品的購買(包括保費支付), 方有資格獲得推廣獎賞。任何經其他渠道(例如 MoneyHero 官方 WhatsApp 帳戶或保險公司網站)進行的投保申請, 將不符合本推廣活動之資格。

## 5. 合資格產品、產品供應商及推廣獎賞

# MoneyHero x Allianz Insurance Promotion (Oct - Nov 2025) (the “Promotion”)

1. This Promotion is organised by MoneyHero Insurance Brokers Limited (“**MoneyHero**”) on behalf of Allianz Insurance (“**Allianz Hong Kong**”).
2. Eligible Customers who successfully purchase an Eligible Product from Allianz Hong Kong during the Promotion Period will receive a Promotion Reward from Allianz Hong Kong, subject to availability as set out herein (each as defined below).

### 3. Promotion Period

Unless otherwise specified, the Promotion Period runs from **October 17, 2025 (6:00 PM) to November 17, 2025 (6:00 PM)** (both dates inclusive) (the “Promotion Period”), subject to the reward quantity limits set out in Clause 5(b).

### 4. Eligible Customers

- a. In order to receive a Promotion Reward as set out in Clause 5 below and to comprise “Eligible Customers”, customers are required to, during the Promotion Period:
  - i. Be a resident of Hong Kong aged 18 or above;
  - ii. Complete the purchase of an Eligible Product (as defined in Clause 4 below) through <https://www.moneyhero.com.hk/zh/car-insurance> or <https://www.moneyhero.com.hk/zh/insurance/car-insurance/best-car-insurance-for-electric-vehicles> during the Promotion Period (including payment of the premium via MoneyHero’s website). If the application is not made via the designated link, or an Ad-blocker, tracking blocker or incognito mode is enabled during the application, it may not be counted as valid and may lead to the customer not being eligible for any rewards. MoneyHero reserves the right to withhold any rewards where, according to its records, the application is not made through MoneyHero in accordance with these Terms and Conditions; and
  - iii. Maintain the Eligible Product in a valid state and not cancel nor be refunded for the Eligible Product prior to Dec 31, based on Allianz Hong Kong’s records.
- b. For the avoidance of doubt, in order to be eligible for a Promotion Reward, a customer must complete the Eligible Product purchase (including payment of the premium) through MoneyHero’s website. Purchases that are made through any other channel (e.g MoneyHero’s official WhatsApp account or the Product Provider’s website) are not eligible for this Promotion.

#### **6. Redemption Process for the Promotion Reward**

- b. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- c. Redemption instructions will be sent to Eligible Customers via email **within 60days** upon confirmation of eligibility from the Product Provider. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting at its absolute discretion) will not be able to receive any Promotion Reward.
- d. Any queries regarding redemption, or redemption submissions of the Promotion Reward that are received after **2026/02/28** will not be handled, except for those already in progress.
- e. Any Promotion Reward(s) not claimed past the stipulated collection period (if any) be forfeited without any liability on the part of MoneyHero to the Eligible Customer. - d. MoneyHero reserves the right to amend these Terms and Conditions at any time, including changing the Promotion Period or Promotion Reward or to terminate this Promotion with or without prior notice.
- e. Participants of this Promotion agree to regularly browse the MoneyHero website to review these Terms and Conditions to ensure that they are fully aware of any changes or changes that MoneyHero may make to these Terms and Conditions from time to time.
