抽獎條款及細則

合資格參加者需符合以下所有條件:

CreFIT "iPhone 17 Pro Max Lucky Draw" Terms and Conditions

Lucky Draw Terms and Conditions

Eligibility Requirements:

- Participants must be aged 18 or above and hold a valid Hong Kong Identity Card.
- 2. Participants must possess a valid Hong Kong mobile phone number.
- 3.
