

MoneyHero 結餘轉戶貸款限時活動 條款及細則 202510 (「推廣活動」)

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶，將獲得推廣獎賞(定義見下文)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2025/10/01 6pm 至 2025/10/31 6pm, 包括首尾兩日(「推廣期」)。

3. 就此推廣活動而言：

4. 合資格客戶

為了獲得推廣獎賞並成為「合資格客戶」，客戶需滿足以下條件：

- 為年滿18歲或以上、持有有效香港身份證及在香港有通訊地址的客戶；
- 在被重定向至產品提供者網站之前，向MoneyHero提供有效的電郵地址；

Terms & Condition of 202510 MoneyHero Debt Consolidation Loan Campaign

1. Eligible Customers who successfully apply for a Designated Loan through MoneyHero during the Promotion Period and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/10/01 6pm to 2025/10/31 6pm, both dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

4. Eligible Customers

In order to receive a Promotion Reward and to comprise “**Eligible Customers**”, customers are required to:

- Be a New Customer who is aged 18 or above, a holder of a valid Hong Kong Identity Card and with a correspondence address within Hong Kong;
- Provide a valid email address to MoneyHero prior to being redirected to the Product Provider’s website;
- Fully complete and submit an application for a Designated Loan through MoneyHero using the designated link during the Promotion Period;
- Fully complete and submit the MoneyHero Reward Redemption Form within 7 days after receiving the MoneyHero Reward Redemption Form from MoneyHero;
- Submit all documents to the Product Provider and have their application for the Designated Loan confirmed by the Product Provider; and
- Have their application for the Designated Loan approved by the Product Provider and complete drawdown for the Designated Loan within 1 month with a drawdown amount of at least HK\$100,000 and repayment period of at least 12 months or above.

5. Promotion Rewards and Redemption

- Eligible Customers who complete the conditions set out in Clause 4a-4f above will be able to select one of the following “Promotion Rewards”, depending on the loan amount, subject to availability:
 - Apple AirPods Pro 3 (value of HK\$1,849).
- Eligible Customers will receive a maximum of 1 Application incentive and 1 Drawdown rewards per application of Designated Loans .

- c. After confirmation of eligibility, redemption instructions will be sent to Eligible Customers via email to the email address provided by the Eligible Customer to MoneyHero. Eligible Customers who provide inaccurate or incorrect information (as determined by MoneyHero acting in its absolute discretion) will not be able to receive any Promotion Reward.
- d. Eligibility for the Promotion Reward will be based on MoneyHero and the Product Providers' internal records. In the event of any disputes, MoneyHero reserves the right to make the final decision in its absolute discretion, which shall be binding on all users.
- e. If the application for the Designated Loan is not made via the designated link, or an ad-blocker, tracking blocker or incognito mode is enabled during the application process, it may not be counted as valid and may lead to the user not being eligible for any Promotion Reward.  - (i) are required to have registered for FPS using the phone number provided to MoneyHero;
 - (ii) agree to receive the Cash Reward via FPS;
 - (iii) are fully responsible for ensuring that the phone number provided to MoneyHero is registered for FPS and the correct phone number linked to their FPS account in their own name; and
 - (iv) acknowledge and agree that once the MoneyHero Reward Redemption Form has been submitted, the phone number provided cannot be amended, and the Cash Reward will not be re-issued to Eligible Customers who have provided incorrect phone numbers.
- h. By selecting a Cash Reward, Eligible Customers confirm that they are in compliance with all Anti-Money Laundering (AML) laws and regulations.
