MoneyHero x WeLend私人貸款條款及細則 202511 (須提取貸款) (「推廣活動」) 202511 MoneyHero x WeLend - Personal Loan - Drawdown Offer

1. 客戶凡在推廣期內通過MoneyHero成功申請指定貸款並完成以下要求的合資格客戶, 將獲得推廣獎賞(定義見下文)。

2. 推廣期
