

MoneyHero x Chief HK 條款及細則 (以下稱「推廣活動」) (202509)

1. 於推廣期內，透過MoneyHero申請指定帳戶，並獲批准且完成此處列明的其他要求的合資格客戶，將獲得推廣獎賞(各自定義如下)。

2. 推廣期

除非另有說明，推廣活動的推廣期為 2025/09/01 6pm 至 2025/09/30 6pm, 包括首尾兩日(以下稱「推廣期」)。

3. 推廣活動相關定義

- a. 「指定帳戶」是指 致富證券。
- b. 「產品供應商」是指 致富證券。
- c. 「新客戶」是指於推廣活動的推廣期首次成功開立致富證券帳戶的用戶。

4. 合資格客戶

b. 合資格客戶將最多獲得1個推廣獎賞。

Terms and Conditions of MoneyHero x Chief HK (the “Promotion”) (202509)

1. Eligible Customers who apply for a Designated Account through MoneyHero during the Promotion Period, are approved for the same and complete the other requirements set out herein will receive a Promotion Reward (each as defined below).

2. Promotion Period

Unless otherwise specified, the promotion period of the Promotion is from 2025/09/01 6pm to 2025/09/30 6pm, dates inclusive (the “**Promotion Period**”).

3. For the purposes of this Promotion:

a. “**Designated Account**” means the Chief Securities Limited.

b. “**Product Provider**” means Chief Securities Limited.

c. “**New Customer**” means Customers who have not opened a Chief Securities Account prior to their application for a Designated Securities Account as part of this Promotion.

4. Eligible Customers

- Philips ADD6920BK RO Water Dispenser (value of HK\$4,288); OR
- HK\$2,000 Apple Store Gift Card; OR
- HK\$2,000 Wellcome Shopping Voucher; OR
- HK\$2,000 HKTVmall e-Shopping Voucher.

b. Eligible Customers will receive a maximum of 1 Promotion Reward.

c. For the avoidance of doubt, in order to comprise "Eligible Customers", a user is only required to fund the Designated Account with the specified amount and is not required to subscribe to or purchase any securities, investment products and/or initiate any transactions or dealings of securities or investment products.
