

MoneyHero - Home Insurance Typhoon Flash Promotion (Jul - Oct 2025) (「推廣活動」) 條款及細則

根據本推廣活動，合資格用戶(定義如下)於推廣期內透過MoneyHero的指定網站成功投保指定保險(定義如下)，每成功投保一件合資格產品，即可獲得一份推廣獎賞。

2. 推廣期

推廣期間自2025年7月至10月期間，香港天文台發出熱帶氣旋警告信號3號或以上時開始，並於該信號降至低於1號或完全取消時結束。推廣期間的具體開始及結束時間，將以香港天文台於其網站上公布的熱帶氣旋警告信號3號或以上的發出及取消時間為準。

3. 參加資格

如要成為可獲取推廣獎賞的「合資格用戶」，參加者必須：

- a. 為18歲或以上的香港居民；及

- b. 合資格客戶須於MoneyHero獎賞換領表格中選擇其推廣獎賞。一經提交，所選擇將不可更改。

MoneyHero - Home Insurance Typhoon Flash Promotion (Jul - Oct 2025) (the “Promotion”) Terms and Conditions

1. Eligible Customers (each as defined below) who successfully purchase an Eligible Product within the Promotion Period through the MoneyHero designated website will receive a Promotion Reward for each Eligible Product purchased (each as defined herein).

2. Promotion Period

The Promotion Period commences when the Hong Kong Observatory issues a Tropical Cyclone Warning Signal No. 3 or higher from Jul 2025 - Oct 2025 and concludes when the same signal is lowered to below No. 1 or cancelled entirely. The precise start and end times of the Promotion Period will be determined by the Hong Kong Observatory's issuance and cancellation times of Tropical Cyclone Warning Signal No. 3 or higher as published on the Hong Kong Observatory website.

3. Eligible Customer

In order to receive a Promotion Reward and to comprise "Eligible Customers", customers are required to, during the Promotion Period:

- a. Be a resident of Hong Kong aged 18 or above;
- b. Complete the purchase of an Eligible Product (as defined in Clause 4 below) through the designated MoneyHero page (<https://www.moneyhero.com.hk/zh/campaign/typhoon-hongkong-2025>) during the Promotion Period (including payment of the premium). If the application is not made via the designated link, or an Ad-blocker, tracking blocker or incognito mode is enabled during the application, it may not be counted as valid and may lead to the customer not being eligible for any rewards. MoneyHero reserves the right to withhold any rewards where, according to its records, the application is not made through MoneyHero in accordance with these Terms and Conditions;
- c. Maintain the Eligible Product in a valid state and not cancel nor be refunded for the Eligible Product; and
