TERMS AND CONDITIONS FOR ALLIANZ PRODUCT PROMOTION ("PROMOTION TERMS")

- 1. This Allianz Product Promotion ("Promotion") is organised by Allianz Insurance Singapore Pte. Ltd. ("Allianz").
- 2. In these Terms and Conditions, 'you' refers to the main policyholder engaging with Allianz Insurance Singapore Pte. Ltd. through our appointed intermediaries.
- 3. This Promotion is valid from 15 Jul 2025 to 31 Oct 2025, both dates inclusive ("Promotion Period").
- 4. By participating in this Promotion, you hereby agree to be bound by these Promotion Terms.
- 5. The Allianz insurance products which are eligible for this Promotion are:

 - c. Allianz Cancer Protect,

 - a. Allianz Accident Protect Plus,
 - b. Allianz Home Protect,
 - c. Allianz Cancer Protect, and
 - d. Allianz Hospital Income Protect.

- 7. You will enjoy a Discount on premiums payable on an Eligible Product if you purchase the product during the Promotion Period and using the relevant Promo Code through:
 - a. an Allianz telemarketing representative; or
 - b. an Allianz intermediary via AZConnect.
- 8. The table below sets out the Discount and/or Reward applicable to each Eligible Product. To qualify, you, as the main policyholder, must purchase the respective Eligible Product(s). A purchase of Allianz Motor Protect or Allianz Electric Motor Protect by you entitles you to a 16.5% discount (equivalent to approximately 60 days of coverage) and a \$60 voucher (applicable for Comprehensive plan). - e. You must provide marketing consent to be contacted via email for all Eligible Product(s) purchased during this campaign period. The marketing consent must not be withdrawn as of the end campaign period.

- 11. Vouchers will be provided to you, the main policyholder only.
- 12. This Promotion is applicable to new applications only during the Promotion Period and will not be valid with other promotions, discounts, offers, vouchers, rebates or privileges, unless otherwise stated by Allianz.

- 16. The decision of Allianz on all matters relating to this Promotion, including determining your eligibility to participate, shall be at Allianz's absolute discretion and will be final and binding.
- 17. In the event of any inconsistency between these Promotion Terms and any brochures, marketing or promotional materials relating to this Promotion, these Promotion Terms shall prevail.
- 18. A person who is not a party to these Promotion Terms has no right under the Contracts (Rights of Third Parties) Act (Cap.53B) to enforce any of these Promotion Terms.
- 19. These Promotion Terms are governed by and construed in accordance with the laws of the Republic of Singapore, and you agree to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
- 20. The Eligible Products are protected under the Policy Owners' Protection Scheme which is administered by the Singapore Deposit Insurance Corporation ("SDIC").
